To obtain a participation certificate, course completion of 70% is required. For a course completion certificate, 100% is required together with the submission of a short written reflection at the end of the course.

- Criteria for attendance include:
 - ① Bachelor's degree in any field (or any graduate or post-graduate degree)
 - ② Minimum of 2 years professional experience in infrastructure, energy, mining or oil and gas project development
- A limited number of exceptional candidates without a Bachelor's degree may be declared eligible by the course leaders on the basis of their professional experience
- Course fee - £500 per student
